WRITTEN TEST FOR RECRUITMENT FOR THE POST OF SUB-INSPECTOR (EXECUTIVE) IN

The Written Test for the candidates, who have qualified in the Physical Measurement/Endurance Test in the recruitment for the post of Sub-Inspector (Executive) in Andaman and Nicobar Police, will be held on 20/12/2014 (Saturday) at 1000 hrs at JNRM, Port Blair. **The candidates are hereby informed to submit two numbers of Photographs & collect their Admit Card in person from recruitment Cell, PHQ on or before 19/12/2014 till 5.00 p.m.**

1. All candidates must bring their Admit Card, examination board/clip board, Pen, Pencil and eraser along with them. Candidates without **ADMIT CARD** will not be allowed to enter the premises or appear in the written examination.
2. All Candidates shall report at the centre of examination one hour before the scheduled commencement of examination.
3. Any candidate who reports after the commencement of the examination will not be allowed to appear in the written test.
4. The candidates shall not carry any kind of paper into the examination hall except the admit card and writing tools. **No calculator/electronic items/mobile** will be allowed inside the examination hall.
5. During the course of the examination any attempt to copy or indulge in any conversation with any other candidates is strictly prohibited. The candidature of the person indulging in such activity will be cancelled.
