

## RECRUITMENT NOTICE

### RECRUITMENT FOR THE POST OF POLICE CONSTABLE (ASSISTANT MECHANIC) IN ANDAMAN AND NICOBAR POLICE FIRE SERVICE.

Applications are invited from eligible candidates for the following post in Andaman and Nicobar Police Fire Service. The number of post, scale of pay and eligibility conditions are given below: -

#### 1. Name of Post – Police Constable (Assistant Mechanic)

Eligibility conditions:

a)	No. of vacancies	01 for General Candidates
b)	Pay Band + Grade Pay	PB-1 Rs.5200-20200 + Grade Pay Rs.2000/-
c)	Age limit (as on 15/04/2013 inclusive)	18 to 25 years for General (Relaxable for five years for Ex-servicemen/Govt. Servant in accordance with the instructions or orders issued by Central Govt.)
d)	Educational Qualification	i) Matriculation from a recognized Board/University ii) Should possess ITI Certificate in Motor Mechanism from a recognized institute. <b>Desirable:</b> Three years experience in repair, maintenance and overhauling of diesel/petrol engine

#### 2. Minimum Physical Standards for the posts

a)	Height	168 cm
b)	Chest (Normal)	81 cm
c)	Chest (Expanded)	85 cm
d)	Weight	50 Kg

#### 3. Physical Endurance Test

The candidates who qualify after physical measurement shall undergo a physical endurance test as per the following standards.

a)	Race	1 mile in 8 minutes 30 seconds -
b)	Long Jump	3.5 mts. (in three chances)
c)	High Jump	1.1 mts. (in three chances)

**Note:** - Candidates have to qualify in each event of Physical Endurance Test; otherwise they will be eliminated at that stage itself.

#### 4. Trade test

The candidates who qualify in the Physical Measurement and Endurance test will have to undergo for a trade test. The trade test for the posts is as follows: -

Sl. No	Name of Post	Marks	Syllabus for Trade test
1	Police Constable (Assistant Mechanic)	30	The candidates shall be provided with vehicles of various categories and asked to identify, locate, explain and if required, fix the problems therein. The defects to be provided for testing the diagnostic capabilities shall relate to the general functioning of the engine, gear box, chassis, cooling system, brakes, transmission, suspension, lubrication, electrical & electronics system etc.

#### 5. WRITTEN EXAMINATION

The candidates who qualify in Trade Test will undergo a written test. The paper will be set both in English and Hindi and the candidates will have to answer either in Hindi or English.

The syllabus for post is as follows: -

Sl. No	Name of Post	Marks	Syllabus
1	Police Constable (Assistant Mechanic)	50	A question paper – I will cover General knowledge, Simple Arithmetic, English language & essay and Question Paper – II will cover basic knowledge of linear and angular measurements, working and principal of two and four stroke petrol and diesel engine, valve timing, transmission, ignition, fuel pump operation, hydraulic and pneumatic brakes system, engine overhauling, Multi Point fuel Injection System, turbocharger etc.

#### 6. INTERVIEW

The candidates who qualify in the written test will be subjected to an interview of 15 marks by a selection board. During the interview the overall personality, aptitude, attitude, general awareness and suitability for the job of the candidates will be judged.

Apart from this, additional marks up to a maximum of 5 marks shall be awarded for achievements in Sports and NCC as follows:-

Candidates should bring all their original certificates regarding their achievements in Sports and NCC at the time of interview.

On the basis of vacancies at the relevant time a final list of successful candidates shall be prepared on the basis of the marks obtained in the written paper, trade test, NCC/Sports marks and interview.

### 7. Medical Examination

Successful candidates shall be subjected to medical examination as given below:

- i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not be Colour Blind.
- ii) The candidate must not have knock knee, flat foot, varicose vein, squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- iii) The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

### 8. HOW TO APPLY

- i) Candidate may submit their application on a plain paper in the format given below along with the self attested copies of certificates of age proof, education qualification and copy of technical qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) to Dy. Superintendent of Police (Estt), Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 25/03/2013 to 15/04/2013.

The submission of any forged document shall entail the registration of a criminal case.

### 9. Closing Date

Application form should be deposited to the Dy. Superintendent of Police (Estt), Police Head Quarter, Atlanta Point, Port Blair latest by 1700 hrs on 15/04/2013.

### 10. Instructions in General

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all stages of the recruitment. The Admit card should be collected by the candidate from 22/04/2013 to 23/04/2013 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair

- ii) Original documents (Educational qualifications, age proof, technical qualification, sports/NCC) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.
- iii) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- iv) Candidates failing at any stage will be eliminated at that stage itself.
- v) The candidates shall prepare for the physical endurance test and participate at their own risk. The A&N Police will not be liable for any damages in the event of any injury or any casualty suffered by a candidate during the test.
- vi) The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- vii) The Physical Measurement, Endurance Test, Written test and Interview will be held at Police Lines, Port Blair and the Trade test will be held at Fire Motor Transport, Fire Brigade (HQ), Port Blair. The date and time shall be communicated in due course through local newspapers, All India Radio etc.
- viii) No TA or DA will be paid to the candidates for attending the selection process or Interview.
