

## RECRUITMENT NOTICE

### RECRUITMENT FOR THE POST OF CONSTABLE (BANDSMAN) IN ANDAMAN AND NICOBAR POLICE.

Applications are invited from eligible candidates for the post of Constable (Bandsman) in Andaman and Nicobar Police. The number of post, scale of pay and eligibility conditions are given below: -

1. **Name of Post** – Constable (Bandsman)
2. **No of vacancies** – 04 (03 vacancies for General Candidates & 01 vacancy of OBC candidates of A&N Islands)

**Eligibility conditions:**

a)	Age limit (as on 07/09/2012 inclusive)	i) Male: 18-25 years for General and 18 to 28 years for OBC candidates ii) Female: 18-30 years for General and 18 to 33 years for OBC candidates iii) (Relaxable upto 5 years for Govt. servant in accordance with the instructions/orders issued by GOI)

### **3. Physical Endurance Test**

The candidates who qualify after physical measurement shall undergo a physical endurance test as per the following standards.

<b>Male</b>	<b>Female</b>
a) 1 mile race (to be completed in 8 minutes 30 Seconds)	a) 0.5 mile race to be completed in 6 minutes.
b) 3.5 feet High Jump ( 3 chances will be given)	b) 3 feet High Jump (3 chances will be given).
c) 10 feet Long Jump (3 chances will be given).	c) 8 feet Long Jump (3 chances will be given).

**Note: -** Candidates have to qualify in each event of Physical Endurance Test, otherwise they will be eliminated at that stage itself.

### **4. WRITTEN EXAMINATION**

The candidates who qualify in Physical Measurement and Physical Endurance Test will undergo a written test. The paper will be set both in English and Hindi. Candidates will have the option of answering in either language except for the portion of language paper, which will contain questions on Hindi and English both.

**The question papers(s) will cover general knowledge, reasoning, simple arithmetic, test of language and essay and will carry 40 marks.**

### **5. INTERVIEW**

The candidates who qualify in the written test will be subjected to an interview of 20 marks by a selection board. During the interview the overall personality, aptitude, attitude, general awareness and suitability for the job of the candidates will be judged. Further the competence in playing of musical instruments used for marching band of Police will be judged and accordingly 40 marks will be awarded for playing the following instrument of his choice.

1. Keyboard (Piano harmonium electrical key board)
2. Guitar
3. Acto Pad (Percussion)
4. Clarinet
5. Trumpet
6. Percussion (drums) Instruments
7. Any other instruments required subsequently

8. Ability to read and play music from musical score sheet - 10 Marks

## 6. Medical Examination

Successful candidates shall be subjected to medical examination as given below:

- i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not be Colour Blind.
- ii) The candidate must not have knock knee, flat foot, varicose vein, squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- iii) The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

## 7. HOW TO APPLY

- i) Candidates may submit their application on a plain paper in the format given below along with the self attested copies of certificates of age proof, OBC category and educational qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) **to Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 13/08/2012 to 07/09/2012.**

The submission of any forged document shall entail the registration of a criminal case.

- ii) Acknowledgement receipt will be issued on deposit of the form which should be retained by the applicant.
- iii) The application submitted to any officers other than those mentioned as authorized above, will not be accepted and no representation in this regard will be entertained. One candidate can submit only one application. If any candidate submits more than one application, his candidature will be rejected.

## 8. Closing Date

Application form should be deposited in the above designated office latest by 1700 hrs on 07/09/2012.

## 9. Instructions in General

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all stages of the recruitment. **The Admit card should be collected by the candidate from 10/09/2012 to 12/09/2012 from the Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair.**
- ii) Benefit of OBC would be given only to those Candidates who belong to the OBC category as notified by the Andaman and Nicobar Administration.
- iii) Original documents (Educational qualifications, age proof, sports/NCC and OBC category) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.



- i) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- v) Candidates failing at any stage will be eliminated at that stage itself.
- vi) The candidates shall prepare for the physical endurance test and participate at their own risk. The A&N Police will not be liable for any damages in the event of any injury or any casualty suffered by a candidate during the test.
- vii) The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- viii) The date, time and venue of Physical Measurement and Physical Endurance Test shall be communicated in due course through local newspapers, All India Radio etc.
- ix) No TA or DA will be paid to the candidates for attending the selection process or Interview.
