

RECRUITMENT NOTICE

SPECIAL RECRUITMENT DRIVE FOR ST CANDIDATES FOR THE POST OF POLICE CONSTABLE DRIVER (EXECUTIVE) IN ANDAMAN AND NICOBAR POLICE MOTOR TRANSPORT

Applications are invited from eligible ST candidates for filling up **08** post of Police Constable Driver (Executive) in Andaman and Nicobar Police Motor Transport. The scale of pay and eligibility conditions are given below: -

1. **Pay Scale :-** PB-1 Rs.5200-20200 + Grade Pay Rs.2000/-

2. **Eligibility Conditions**

a)	Age limit (as on 30/01/2013)	18-30 years (Relaxable upto 05 years for ST Govt. Servants in accordance with the instructions/orders issued by the GOI from time to time)
b)	Educational/ Technical Qualification	a) 10 th pass from a recognized Board/University b) Valid Light/Heavy Motor Vehicle driving License with knowledge of Motor Mechanism. c) Should possess minimum physical standards i.e. i) Height - 160 cm ii) Chest (Normal) - 77 cm iii) Chest (expanded) - 81 cm iv) Minimum weight - 47 kg v) Desirable 1. Technical qualification in the profession with two years experience in Motor Mechanism 2. Two years experience of driving all types of vehicle 3. Ability to drive motorcycle Note The candidates selected for appointment will have to undergo a training course for a period of 03 months and pass the training.

3. **Physical Endurance Test**

All those candidates who qualify physical measurement shall undergo physical endurance test as per the following standards.

Note: -

- i) Candidates have to qualify in each event of Physical Endurance Test, otherwise he will be eliminated at that stage itself.

4. **Written Test (60 Marks)**

All those candidates who qualify the Physical Measurement and Endurance Tests shall be put through a written examination of 60 marks. A question paper covering General Knowledge, Simple Arithmetic and English language. The paper will be set both Hindi and English and the candidate may answer either in Hindi or English. The minimum qualifying marks in the written test will be 30%. All the candidates who obtain 30% marks in the written test will be called for Trade Test.

5. **Trade Test (25 marks)**

The candidates who qualify in the written test will be required to qualify in the trade test of 25 marks, which will include:-

Only those candidates who obtain 30% or more marks in the trade test will be considered qualified in trade test.

6. Interview / Personality Test (10 marks)

The candidates who qualify in the trade test will be called for an interview /personality test. The interview will carry 10 marks. The candidates will judge on overall personality, aptitude, attitude, general awareness and suitability for the job by Selection Board.

7. Marks for achievement in NCC/Sports (05 marks)

05 marks at the maximum will be awarded for achievement in NCC and/or Sports at the time of tabulation of result as per the scale given below:-

The final list of the successful candidates based on aggregate of 100 marks will be finalized soon after conclusion of the interview and the list of selected candidates shall be declared depending on the number of vacancies notified/ existing.

8. Medical Standards

Successful candidates shall be subjected to medical examination as given below:

- Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not be Colour Blindness.
- The candidate must not have knock knee, flat foot, varicose vein, squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

09. HOW TO APPLY

- Candidates may submit their application on a plain paper in the format given below along with the self attested copies of certificates of age proof, ST category, copy of driving license and educational qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) **to the Dy. Superintendent of Police (Estt), Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 31/12/2012 to 30/01/2013**.
- The submission of any forged document shall entail the registration of a criminal case.

10. Closing Date

Application form should be deposited to the Dy. Superintendent of Police (Estt), Atlanta Point, Port Blair latest by **1700 hrs on 30/01/2013**

11. Instructions in General

- After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all, stages of the recruitment. **The Admit card should be collected by the candidate from 07/02/2013 to 09/02/2013 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair**
- Benefit of ST would be given only to those Candidates who belong to the ST category as notified by the Andaman and Nicobar Administration.
- Original documents (Educational qualifications, age proof, driving license, sports/NCC and ST (category) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/certificates only at the time of interview.

- iv) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- v) Candidates failing at any stage will be eliminated at that stage itself.
- vi) The candidates shall prepare for the physical endurance test and participate at their own risk. The A&N Police will not be liable for any damages in the event of any injury or any casualty suffered by a candidate during the test.
- vii) The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- viii) The Physical Measurement and Endurance Test will be held at Police Lines, Port Blair.
- ix) No TA or DA will be paid to the candidates for attending the selection process or Interview.
