Note: -

- 1) **For transfer from Nicobar group only:** - the transfer orders shall become effective only upon the completion of tenure in respect of each personnel. Hence the concerned SP District should ensure that the under transfer personnel is relieved only after completion of 365 days (except those who were posted for 02 years) in Nicobar District. Information of each personnel being relieved shall be intimated in advance to PHQ so that the reliever can be provided without any delay.
- 2) Concerned District/Unit SPs Shall ensure that the transferred personnel are relieved immediately.
- 3) All Unit In-Charges are directed to furnish compliance report of relieve/duty report of staffs to Establishment Section PHQ.
- 4) Representations, if any shall be entertained only after joining at their new place of posting.
- 5) SHOs to transfer the case file in CCTNS (CAS) system before relieving the IOs. Also, IOs are required to close the dependencies in the CCTNS System before getting relieved from the PS. It should be complied strictly.
