### **Transfer Policy in Andaman & Nicobar Police**

In terms of Rule 6.20(a) of the Andaman & Nicobar Police Manual, 1963, all enrolled police officers are liable to serve in any part of the General Police Districts (Andaman & Nicobar Islands) under section 22 of Police Act. While deciding the postings and transfer of the police personnel, it is endeavored to ensure that all officers /men get equal opportunity of working in different Unit/Branches/Stations in A&N Police and there is equitable distribution in postings to difficult Stations/remote areas.

For this purpose, the various Unit/Branches/Stations in A&N Police department including Executive branch, Police Radio Organization (PRO), Police Marine Force (PMF) & Fire Service are broadly divided into following four groups on the basis of difficulty/remoteness of the area and their tenures fixed accordingly.

The transfer of police personnel for all posts (upto the rank of Inspectors) has been divided into 4 groups (Group "A" to "D") and following transfer policy is generally followed for these groups:

The A&N State Police Establishment Board(SPEB) decide transfer of police personnel on rotational basis so that police personnel get fair opportunity to serve in soft as well as hard areas. However a few policemen who have specialized in certain technical activities, specialized field of police activity or engaged in administrative work (in absence of separate ministerial cadre) are exempted from transfer on rotational basis as per policy.

As per transfer policy issued by A&N Administration vide circular No.55-3/2003-PW dated 30.07.2007 consideration has been given to the officials of A&N Police having less than 02 years of service left, to avoid their transfer & posting in the remote areas where adequate medical facilities are not available. Furthermore, while deciding transfers and posting requests of officials whose children's are studying in class 10<sup>th</sup> & 12<sup>th</sup>, medical condition of the Govt. Servant etc. are considered sympathetically and accommodated.

Apart from this the instructions/guidelines issued by A&N Administration on transfer policy from time to time shall also be followed by A&N Police department.

This supersedes all previous orders/circulars etc. issued in this regard.
